Delinquent accounts balance over \$400 are at \$10,530.24, down from \$11,754.24 in October. Mrs. Vessey was able to receive payment on 5 accounts, however, there are still 9 accounts over \$500, down from 12 last month.

MAINTENANCE: Chuck Vessey

Normal winter maintenance is being done on lift stations as well as manhole checks during locates, and hydro-cleaning/tving lines during good weather. There were no backups last month.

647 COUNTRY CLUB ROAD: Chuck Vessey

The homeowner is wanting to rezone this lot to put in an additional house, extending the sewer line with an 8" main and a 20' easement. Currently, they just want pre-liminary approval before providing plans. Preliminarily the board saw no issues with the proposal but will not approve without engineered plans. This month the board is asking for a 30' easement rather than 20'.
